200-word entry synopsis

Provide a clear, concise, and coherent summary of your project, service, team, or individual achievements. Focus on highlighting key accomplishments and the impact of your work.
Note: Ensure the synopsis is straightforward and serves as an overview, with further details to be expanded upon in the main entry.

1500-word statement

Craft a comprehensive statement tailored to the specific category you are entering. This section will be thoroughly evaluated by our panel of judges and should encompass all key aspects you want the judges to consider when assessing your entry. Review the category details and criteria provided below to ensure your statement addresses all relevant aspects.

Project Awards statement

For banks and financial institutions, winning a PayTech Award proves the value of their technology investments and showcases their skills, commitment, creativity, and execution.

Please provide a comprehensive account of the project that essentially answers the questions of “what, why, how” and demonstrates tangible benefits. This includes:

- What the project is, explained in clear, layman’s terms
- The rationale of the project and its importance
- Solutions, technology, and relevant processes
- Project participants, collaboration
- Journey, stages, and milestones
- Challenges and how they were solved
- What problems the project solved on a business level and what improvements it delivered – supporting evidence, stats and facts are crucial.

The project must be recent (within the last two years) and be largely completed – the results and benefits must be tangible and measurable.

Excellence in Tech Awards statement

For technology services and software providers, our awards offer valuable recognition and endorsement by the industry, underpinned by unbiased expertise and unrivalled reputation.

Please provide a comprehensive account of the product that essentially answers the questions of “what, why, how” and demonstrates tangible benefits to its users. This includes:

- What the solution is, explained in clear, layman’s terms
- Functionality
- Technology and relevant processes
- What makes it unique or standout
- What problems it solves on a business level and what improvements it delivers – supporting evidence, stats and facts are crucial
- Use cases and examples of how it has delivered tangible benefits
- The solution must be operational and have at least one live site.

Individuals statement

Please provide a comprehensive account of the nominated person and their work, including:

- Their accomplishments beyond their standard day-to-day job duties
- Their own contribution towards the success their company/business/project/etc
- The results of their work and the supporting evidence
- Their contribution to the industry’s betterment, for example, mentorship projects, contribution to charitable causes, diversity & inclusion initiatives, and so on.

A successful nomination will be to the point and with supporting evidence, not buzzwords. We do not want to see press releases, advertorials, or sales & marketing brochures.

This award is for an individual, so make the nomination about them and why they deserve to win!

Teams statement

Please provide a comprehensive account of the nominated team and its work, including:

- The composition of the team, responsibilities, etc
- How the team operates and collaborates
- The team’s direct contribution towards the success of their company/business/project/etc
- The issues they solve and how they do it
- The results of their work and the supporting evidence
- Any extracurricular activities, such as charity work, pro-bono projects etc.

A successful nomination will be to the point and with supporting evidence, not buzzwords. We do not want to see press releases, advertorials, or sales & marketing brochures.

This award is for a team, so make the nomination about them and why they deserve to win!

Entry tips

Understand the criteria

Familiarize yourself thoroughly with the criteria for the award category you're applying to. Tailor your application to address each criterion effectively.

Be clear and concise

Write in clear, concise language, avoiding jargon or overly technical terms. Ensure your application is easy to understand for the judges.

Focus on impact

Emphasize the impact of your project, product, service, individual, or team. Clearly articulate the problem you addressed, the solution implemented, and the measurable benefits or outcomes achieved.

Provide evidence

Back up your claims with solid evidence, such as statistics, metrics, case studies, or testimonials. Concrete data lends credibility to your application and demonstrates the tangible results of your efforts.

Tell a compelling story

Craft a compelling narrative that captivates the judges and highlights the uniqueness and significance of your initiative. Share anecdotes, success stories, and real-world examples to illustrate your achievements.

Tailor to the category

Customize your application to fit the specific requirements of the award category. Address each aspect of the nomination criteria and ensure your application aligns with the focus and objectives of the award.

Avoid promotion

Steer clear of promotional language, marketing materials, or sales pitches. Focus on presenting factual information and meaningful insights rather than using buzzwords or exaggerated claims.

Be authentic

Be genuine and transparent in your application. Highlight your strengths, accomplishments, and contributions honestly and authentically. Judges appreciate sincerity and integrity in award submissions.

Proofread and edit

Thoroughly proofread and edit your application for grammar, spelling, and clarity. A well-polished and error-free submission reflects professionalism and attention to detail.
